Los Angeles Children's Chorus Board of Directors Need-Based Financial Assistance Policy

Financial assistance is available on a need basis to help Los Angeles Children's Chorus (LACC) families cover the costs of their chorister's participation in LACC programs.

Financial assistance awards are limited to the funds available each year.

Financial assistance applications are reviewed in confidence and need-based awards are granted at the discretion of the Finance Committee of LACC's Board of Directors. Anonymity of the applicant and confidentiality of financial information are maintained throughout the review process and thereafter. LACC's Executive Director and Business Manager communicate financial assistance decisions.

To qualify for financial assistance, families must adhere to the following procedures:

- Financial assistance applications for the upcoming season are due to the LACC Business Manager by:
 - June 1st for returning choristers.
 - One week after the end of auditions for auditioning children.
 - October 1st for tours.
 - November 1st for day trips
- Late applications will not be accepted.
- Choristers not adhering to LACC Chorister Handbook policies may be subject to disciplinary action including the loss of their financial assistance.
