



PERMISSION AND RELEASE FORM

The safety and well being of your child is of paramount importance to LACC and the chaperones, employees, administrators, directors and volunteers of LACC. All reasonable care and precautions are taken to ensure a safe educational and entertainment experience. The following release is both a requirement of insurance coverage and an important reminder to you as a parent to be sure that your child is properly prepared.

I (we) the undersigned parent(s) and/or guardian of _____ do state and affirm that I am (we are) the legally authorized guardian(s) of the above named child, and I (we) also give permission for him/her to travel with the Los Angeles Children's Chorus to all events scheduled by LACC including concert tours to various locations within the United States or abroad.

My son's/daughter's participation in Los Angeles Children's Chorus is purely voluntary and I elect to have him/her do so at my own risk. I certify that my son/daughter is in sufficient physical condition to participate in the rehearsal, performance and/or tour activities of the Chorus. I also agree to instruct my son/daughter to abide by the rules or instructions given to them either verbally or in writing by LACC. I further understand that LACC reserves the right to refuse any person judged to be physically or mentally unfit to meet the rigors and requirements of participating in any Chorus activity or trip.

In the event of illness or accident of my child, any employee, volunteer, associate, administrator, director, or chaperone of LACC, in whose care my child has been entrusted, is authorized to consent to an X-ray, examination, anesthetic, medical, or surgical diagnosis of my child; to the transportation of my child under general or special supervision, and to treatment upon the advice of a licensed physician and/or surgeon. I hereby indemnify, discharge, and hold harmless LACC, Pasadena Presbyterian Church and any employee, volunteer, associate, administrator, director, or chaperone from any liability because of the exercise of such consent. I (we) agree to assume responsibility for all expenses incurred by LACC in order to obtain medical care for my (our) child.

In the event that the adult representatives of LACC decide that my (our) child must leave an event for medical, behavioral, or other unforeseen reasons, I (we) agree to assume responsibility for all costs related to his/her return trip home separate from the tour. In case of hospitalization, I (we) agree to fly to the concert location to tend to my (our) child.

In return for LACC allowing my child to participate in this activity, I voluntarily agree to release, discharge and hold harmless LACC, its directors, employees, associates, agents, and chaperones and Pasadena Presbyterian Church from all actions causes, damages, claims, or demands which the undersigned or said child or any successor my have against LACC or such other parties, for all personal injuries, property damage, or other type of loss or damage of any kind, whether or not presently known or contemplated, which my be incurred during a Chorus event, outing, or tour, including transportation. Each person signing below acknowledges that he/she has read this release, understand all of its terms and their significance and has executed this release voluntarily.
